# **FOREWORD**

This publication, issued as a supplement to the "Directory of Visiting Scholars in the United States under the Fulbright-Hays Act", includes the names of those scholars who have informed the Committee on International Exchange of Persons that they would be available for occasional lectures at other than their host institutions during the academic year 1966-67.

The list is arranged by geographic areas and indicates the country and field of specialization of each scholar as well as some of the topics on which he would be willing to lecture. This classification has been used since many of the scholars are prepared to speak on general topics relating to their national history and culture rather than, or in addition to their own specialized academic disciplines.

Although the scholars hold teaching or research appointments and may have limited time for visits to other institutions, many would be able to arrange their schedules to permit brief absences from their assignments. It would be appropriate to extend an invitation directly to any scholar on the list in care of the indicated faculty associate or department at his host institution, or letters may be addressed to the scholars in care of the Committee. If additional information concerning a scholar's suitability as a speaker is desired, the faculty associate or the head of the sponsoring department may be consulted before an invitation is extended. For example, some scholars might be more effective with small groups or in seminars than with large audiences, and it should be noted also that in certain cases the scholar's facility in the use of English may be somewhat limited. It is hoped that any scholar who is invited as a guest speaker will have his travel and incidental expenses provided, and an honorarium, even though modest, would be appreciated.

It is important that the Committee be sent a copy of any invitation extended to a visiting Fulbright-Hays scholar. A brief report on his visit would also be helpful in determining the usefulness of this list.

Awards to foreign scholars under the Fulbright-Hays Act are administered in cooperation with binational Commissions/Foundations or United States Embassies in the participating countries. Travel grants are usually awarded for an initial period of not less than three months nor longer than one year to supplement stipends provided by American universities for lecturing or research appointments. Under certain specified conditions, the tenure of the grant may be extended to permit a scholar to remain in the United States two years and, under exceptional circumstances, an extension for a third year may be approved for a scholar engaged in research. Travel grants for lecturers are limited to a maximum of two years.

The following procedures are outlined for American institutions wishing to offer a lecturing or research appointment to a foreign scholar under the sponsorship of the Fulbright-Hays exchange program.

# (1) Direct Invitation to a Foreign Scholar

If an American university knows a particular foreign scholar it wishes to appoint on a temporary basis, an invitation may be extended directly to the scholar, and he can be advised to apply for a travel grant through the binational Commission/Foundation or the United States Embassy in his own country. The letter of invitation should indicate the nature of the desired assignment, the period of time to be spent at the university, and the stipend to be paid. This letter will be attached to the scholar's application as evidence of his dollar support and institutional connection in the United States.

# (2) List of Foreign Scholars Available for Remunerative Appointments

Each year a number of foreign scholars are nominated provisionally by the binational Commissions/Foundations abroad for travel grants on condition that remunerative teaching or research positions will be offered them by educational institutions in the United States. A list of these scholars is prepared by the Committee on International Exchange of Persons early in the calendar year and contains brief biographic data on each scholar. The Committee will be pleased to mail this list, upon request, to any interested institution.

# (3) Announcement of Positions Available for Foreign Scholars

If a university wishes the assistance of a binational Commission/ Foundation abroad in finding a qualified candidate for a particular research or teaching position, a letter to this effect should be sent to the Committee on International Exchange of Persons. Such requests should be made well in advance and only when a university seriously wishes a foreign scholar to fill a position and is willing to hold it open for a sufficient period to allow the Commissions/ Foundations time to explore the availability of qualified candidates and submit applications.
